

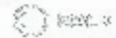

326361231 Special Events Fee (any event whereby police officers are requested to be present This shall include, but is not limited to, any activity on the highways/roadways, highway/roadway closures, traffic directions and/or closure for construction, funeral and other escort services, carnivals, parades, and running/walking events.)

\$100.00 per officer, per 4 hour period (4 hours minimum), plus 48.5 cents per mile when official vehicles are used
Mileage rate is adjusted annually based on IRS Regs.

~~For the purposes of this fee schedule, the definition of a false alarms shall be as follows:~~

~~False Alarms: The dispatch of police on alarm signal activation when there is no evidence of a crime, attempted crime or other activity that would warrant a police response.~~
