CHARGE ONE

On or about the 13th day of July 2015, in Guam, MARK ANTHONY TORRE, JR. did commit the offense of *Murder*, in that he recklessly caused the death of another human being, that is, *Elbert G. Piolo*, under circumstances manifesting extreme indifference to the value of human life, in violation of 9 GCA § 16.40(a)(2) and (b).

SPECIAL ALLEGATION
*Possession or Use of a Deadly Weapon
in the Commission of a Felony*

On or about the 13th day of July 2015, in Guam, MARK ANTHONY TORRE, JR. did knowingly and unlawfully possess or use a deadly weapon, that is, *a pistol*, in the commission of a felony, that is, *Murder (As a 1st Degree Felony)*, as alleged in the First Charge above, in violation of 9 GCA § 80.37.

CHARGE TWO

On or about the 13th day of July 2015, in Guam, MARK ANTHONY TORRE, JR. did commit the offense of *Manslaughter*, in that he recklessly caused the death of another human being, that, *Elbert G. Piolo*, in violation of 9 GCA § 16.50(a)(1).

SPECIAL ALLEGATION
*Possession or Use of a Deadly Weapon
in the Commission of a Felony*

On or about the 13th day of July 2015, in Guam, MARK ANTHONY TORRE, JR. did knowingly and unlawfully possess or use a deadly weapon, that is, *a pistol*, in the commission of a felony, that is, *Manslaughter (As a 1st Degree Felony)*, as alleged in the Second Charge above, in violation of 9 GCA § 80.37.

CHARGE THREE

On or about the 13th day of July 2015, in Guam, MARK ANTHONY TORRE, JR. did commit the offense of *Aggravated Assault*, in that he did recklessly cause serious bodily injury to

1 another, that is, *Elbert G. Piolo*, in circumstances manifesting extreme indifference to the value of
2 human life, in violation of 9 GCA § 19.20(a)(1) and (b).


11 On or about the 13th day of July 2015, in Guam, MARK ANTHONY TORRE, JR. did
